
He/She should exercise option for fixation of pay under FR 22(I)(a)(1) within a period of one month from date of taking over charge of new assignment. Further, it may be noted that the ad-hoc period shall not be counted for financial up-gradation under MACP as per Rules.

It may be ensured that the concerned officials should be on duty on the date of effect of promotion and he/she was not on any kind of leave. If he/she was on leave, his/her date of joining will be on the date of attending office. If the date of effect of promotion falls on holiday or Saturday or Sunday, the date of promotion shall be applicable on the next working day.

This Office Order supersedes all the previous Office Orders issued on or after 20.03.2012 in respect of the above officials for promotions to the posts of Upper Division Clerks.
