The labour education programmes emphasize gender sensitivity in its programmes and tries to emphasize the workers about transformations to the knowledge age, preparing them to face the challenges of globalization through training and education. The DTNBWED also aims to bring about consciousness among workers about their rights, duties and responsibility and awareness generation about the activities / scheme being implemented for the welfare of workers working in rural and unorganized sectors.

1. OUR VISION

DTNBWED dedicates itself in creation of values in training and education to promote inclusive growth, harmony and sustainability in all segments of workforces and social partners of production and services in organized, rural and unorganized sectors for igniting the minds of learners in their fields of accomplishment.

2. OUR MISSION

- a) To develop patriotism among the workforce of India with commitment to communal harmony and national integration.
- b) To develop greater understanding of the issues concerning the society for equipping those to shoulder higher level responsibilities and intelligent participation of the workforce in the socio-economic and cultural development of the nation.
- c) To build the competence of the trade unions through enlightened members to instill sensitive and responsible internal leadership and to ensure that workers education becomes a cardinal feature of trade union functions.
- d) To strengthen the workforce in rural, organized and unorganized sectors by imparting knowledge, information, skill, tools, techniques and support to form co-operative societies, self-help groups and other forms of self employment and livelihood promotions for contributing intelligently to the overall development and inclusive growth of the nation.
- e) To bring out dormant creative capacities of each from within the workforce by encouraging scientific thinking and awakening spiritual powers to lead a value based life, which will take to the level of self actualization.
- f) To continually improve the competence of the employees of DTNBWED through training communication, research, consultancy, ethical practices, and by reaching people to be capable of carrying out the activities of international standards.

3. OBJECTIVES

- (i) To strengthen among all sections of the working class, including rural workers, a sense of Patriotism, National Integrity, Unity, Amity, Communal Harmony, Secularism and pride in being an Indian;

- (iii) To develop amongst the workers and greater understanding of the problems of their social and economic environment, their responsibilities towards family members, and their rights and obligations as citizens, as workers in industry and as members and officials of their Trade Union;

- (v) To develop strong, united and more responsible trade unions and to strengthen democratic processes and traditions in the trade union movement through more enlightened members and better trained officials;
- (vi) To empower the workers as employees of the organization and to develop sense of belongingness as effective instruments of amicable industrial relations and maintaining industrial peace;
- (vii) To meet the needs of workers to have access to way of acquiring and continuous up-gradation of knowledge and skills that they require to find and hold a job.

4. ADMINISTRATIVE SET-UP

The DTNBWED is functioning through 50 Regional Directorates, 7 Sub-Regional Directorates spread across the country. These Regional Directorates are being controlled by 6 Zonal Directorates located at New Delhi, Mumbai, Kolkata, Chennai, Guwahati and Bhopal. In addition, an apex training institute, Indian Institute of Workers Education is located at Mumbai which conducts programmes for the members of various Trade Unions.
