OFFICE ORDER

In pursuance to O.M. vide No. 35034/3/2015-Estt.(D) dated 22nd October, 2019 issued by Department of Personnel and Training, Government of India regarding guidelines on Modified Assured Career Progression Scheme (MACP) for the Central Government Civilian Employees and as per recommendations of the Departmental Screening Committee meeting held by circulation on 01.10.2020, the following Officials are eligible for grant of One/ Two / Three financial up-gradation as indicated against his / her name on completion of 10/20/30 years of service and are placed in the higher Grade Pay with effect from the dates mentioned against their names:-

Since the benefit of Pay Fixation available on regular promotion shall also be applicable at the time of financial up-gradation under MACP Scheme, therefore the employees have an option under FR(I)(a)(1) to get his/her pay fixed in the higher Grade Pay / Post either from the date of his/her upgradation order or from the date of his next increment should be exercised within one month of the date of MACP upgradation / promotion.

There shall, however be "NO" further pay fixation benefit applicable at the time of regular promotion in terms of Para-4 of the MACP scheme dated 19.05.2009.

This Office Order supersedes earlier Office Order issued vide No. A-28013/MACP/12-17/Gr. C/1904-1905, 1906-1907, 1922-1923, 1928-1929 dated 5th November, 2018, No. A-28013/MACP/6-2019/2234-2265 dated 11th September, 2019 in respect of the above officials.

However, the officials, whose names are not mentioned in the earlier Office Order issued on 5th November, 2018 and 11th September, 2019 will be eligible for MACP up-gradation as per the dates and Pay Level mentioned as against their names in the aforesaid Office Order.

This is issued with the approval of the competent authority.
