The above officer should exercise option for pay fixation of pay under FR 22(I)(a)(1) within a period of one month from date of taking over charge.


The Officers, who have been promoted to the post of Regional Director and posted to the respective places as mentioned above, are entitled to get Transfer TA and joining time as per Rules.
