OFFICE ORDER

In pursuance of the introduction of Modified Assured Career Progression Scheme (MACP) for the Central Government Civilian Employees vide Government of India, Ministry of Personnel, Public Grievances and Pensions, Department of Personnel and Training O.M. No. 35034/3/2008-Estt.(D) dated 19th May, 2009 and approval for grant of the said benefits to the employees of Dattopant Thengadi National Board for Workers Education and Development (DTNBWED) (formerly CBWE) granted vide Ministry of Labour and Employment letter No. Z-20025/19/2010-ESA(WE) dated 1st January, 2014, and as per recommendation of the Screening Committee meeting held on 23.09.2020, the following Officials are found eligible for grant of One/ Two / Three financial upgradation indicated against his / her name on completion of 10/20/30 years of service and are fulfilling the prescribed conditions are hereby granted First/ Second / Third MACP and are placed in the higher Grade Pay with effect from the date against their names:-

Since the benefit of Pay Fixation available on regular promotion shall also be applicable at the time of financial upgradation under MACP Scheme, therefore the employees have an option under FR(I)(a)(1) to get his/her pay fixed in the higher Grade Pay / Post either from the date of his/her upgradation order or from the date of his next increment should be exercised within one month of the date of MACP upgradation /

There shall, however be "NO" further pay fixation benefit applicable at the time of regular promotion in terms of Para-4 of the MACP scheme dated 19.05.2009.
