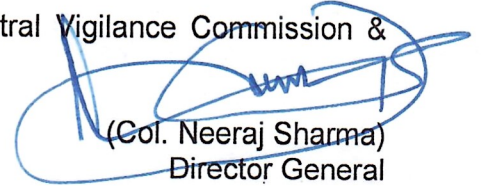
Office Order

In pursuance of the Central Vigilance Commission's (CVC) Office Memorandum No. 4S-CVO-31 dated 01/10/2025, Shri Sanjay Kumar, Regional Director, DTNBWED, New Delhi is hereby appointed as the Part-time Chief Vigilance Officer (CVO) of the Dattopant Thengadi National Board for Workers Education and Development (DTNBWED) and assumes the charge with immediate effect.

The appointment is for a period up to 31/01/2028 (i.e., till the date of his retirement or superannuation which is 28/02/2027) or until further orders, whichever event occurs earlier. Shri Sanjay Kumar shall perform the duties of the Part-time CVO in addition to his existing responsibilities as Regional Director without any extra remuneration. 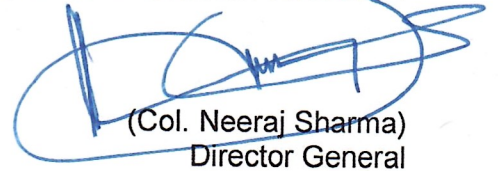
